- SB 0006 Relating to Education Personnel** Thrasher  
Education Personnel [SPSC]; Authorizes the release of child abuse records to certain employees and agents of the Department of Education. Requires school districts to develop and implement end-of-course assessments. Creates the Performance Fund for Instructional Personnel and School-Based Administrators. Limits bonuses under the Dale Hickam Excellent Teaching Program to individuals who remain continuously employed in a public school in this state, etc. EFFECTIVE DATE: 07/01/2010 except as otherwise provided.

- HB 0007 Relating to Coverage for Mental and Nervous Disorders** Homan  
Coverage for Mental and Nervous Disorders: Revises requirements & limitations for optional coverage for mental & nervous disorders; repeals provisions relating to optional coverage required for substance abuse impaired persons; provides for application. Effective Date: January 1, 2011, and shall apply to policies and contracts issued or renewed on or after that date

- SB 0010 Relating to Balanced Federal Budget** Atwater  
Balanced Federal Budget [SPSC]; Urges Congress to call a convention for the purpose of proposing amendments to the Constitution of the United States to provide for a balanced federal budget and limit the ability of Congress to dictate to states requirements for the expenditure of federal funds

Crimes Against Homeless Persons: Reclassifies offenses evidencing prejudice based on homeless status of victim. Effective Date: October 1, 2010

- HB 0015 Relating to Department of Elder Affairs** Pafford  
Department of Elder Affairs: Proposes amendment to s. 12, Art. IV of State Constitution to redesignate Department of Elderly Affairs as Department of Elder Affairs. Effective Date: Not Specified

- HB 0031 Relating to Public Education** Drake  
Public Education: Prohibits district school boards, administrative personnel, & instructional personnel from discouraging or inhibiting student delivery of inspirational message at noncompulsory high school activity; prohibits district school boards, administrative personnel, & instructional personnel from taking affirmative action that infringes or waives rights or freedoms afforded by First Amendment

to United States Constitution. Effective Date: July 1, 2010

- HB 0037 Relating to Health Care Services** Plakon  
Health Care Services: Proposes creation of s. 28, Art. I of State Constitution to prohibit laws or rules from compelling any person, employer, or health care provider to participate in any health care system, permit person or employer to purchase lawful health care services directly from health care provider, permit health care provider to accept direct payment from person or employer for lawful health care services, exempt persons, employers, & health care providers from penalties & fines for paying or accepting direct payment for lawful health care services, & permit purchase or sale of health insurance in private health care systems; specifies what amendment does not affect or prohibit. Effective Date: Not Specified

- HB 0091 Relating to Adult Protective Services** Wood  
Adult Protective Services: Revises legislative intent with respect to adult protective services; provides for care & protection of all vulnerable adults; provides for certain suspected abuse cases to be transferred to local county sheriff's office; provides for DCFS to file petition to determine incapacity & guardianship; authorizes DHSMV to provide copies of drivers' license files to DCFS to conduct protective investigations. Effective Date: July 1, 2010

- SB 0094 Relating to Streamlined Sales and Use Tax Agreement** Lynn  
Streamlined Sales and Use Tax Agreement [WPSC]; Urges the Congress of the United States to enact legislation to authorize states that have complied with the Streamlined Sales and Use Tax Agreement to require out-of-state sellers to collect each such state's sales and use tax.

- HB 0107 Relating to Autism** Coley  
Autism: Requires that physician refer minor to appropriate specialist for screening for autism spectrum disorder; provides health insurance coverage for individuals with certain developmental disabilities; requires certain insurers & HMOs to provide direct patient access to appropriate specialist for screening, evaluation, or diagnosis for autism spectrum disorder or other developmental disabilities; requires insurer's policy or HMO contract to provide for minimum number of visits per year for such screening, evaluation, or diagnosis. Effective Date: July 1, 2010

- HB 0117 Relating to Childhood Vaccinations** Ambler  
Childhood Vaccinations: Revises requirements for administration of certain vaccines required for school entry; requires licensed health care providers to provide certain vaccine information statements to parents, legal guardians, & legal representatives before administration of certain vaccines to children; requires health care providers to obtain signed statements from parents, legal guardians, & legal representatives documenting that vaccine information statements are provided; specifies required contents of signed statements; requires health care providers to record batch & lot number of each vaccine on signed statements; requires health care providers to maintain certain records; provides for application of act to certain vaccine information statements; authorizes use of single signed statement for administration of multiple vaccines under certain circumstances. Effective Date: July 1, 2010

- SB 0124 Relating to School Entry Requirements/Swimming Life Skills** Bullard (L)  
School Entry Requirements/Swimming Life Skills [SPSC]; Requires that children who enter public or private schools in the state present evidence of having completed a class in swimming life skills conducted by a certified instructor. Provides for certain exemptions from the requirement. Amends specified provisions relating to student and parent rights and requirements for private schools, etc. EFFECTIVE DATE: 07/01/2010.  
12/9/2009 SENATE Referred to Education Pre-K - 12; Children, Families, and Elder Affairs; Education Pre-K - 12 Appropriations
- SB 0146 Relating to Senior Services/Independent Special Districts** Rich

Senior Services/Independent Special Districts [WPSC]; Authorizes a county to create an independent special district by ordinance to provide funding for services for seniors. Requires approval by a majority vote of electors to annually levy ad valorem taxes. Creates a governing council for the district. Requires the council to prepare a tentative annual budget and compute a millage rate to fund the district. Provides legislative intent with respect to the use of funds collected by the council, etc. EFFECTIVE DATE: 07/01/2010.

**SB 0148 Relating to Employment for the Homeless** Ring  
Employment for the Homeless [WPSC]; Specifies the order for applying the tax credit for employment of the homeless, etc. EFFECTIVE DATE: 07/01/2010.

**HB 0153 Relating to Senior Services** Pafford  
Senior Services: Authorizes each county to create by ordinance independent special district to provide funding for services for seniors; requires elector approval to annually levy ad valorem taxes; requires district to comply with statutory requirements related to levying & fixing millage & filing financial or compliance reports; provides for dissolution of district; creates district governing council; specifies council powers & functions; specifies council responsibilities & duties; authorizes two or more districts to enter into cooperative agreements; requires council to prepare tentative annual budget & compute millage rate to fund district; requires tax moneys collected to be paid directly to council by county tax collector & deposited into qualified public depositories; requires specified members to file surety bond; specifies expenditures of funds; requires council to prepare & file quarterly financial reports with county governing body; prohibits council from requiring specified matching funds. Effective Date: July 1, 2010

**HB 0179 Relating to Child Safety Devices In Motor Vehicles** Steinberg  
Child Safety Devices In Motor Vehicles: Revises child-restraint requirements; provides child-restraint requirements for children 4 through 7 years of age who are under 4 feet 9 inches tall; redefines term "motor vehicle" to exclude certain vehicles from such requirements; provides exceptions to such requirements; provides grace period. Effective Date: upon becoming a law  
12/22/2009HOUSE Withdrawn prior to introduction

**SB 0182 Relating to Coverage for Mental and Nervous Disorders** Crist  
Coverage for Mental and Nervous Disorders [CPSC]; Revises requirements and limitations for optional coverage for mental and nervous disorders. Specifies nonapplication under certain circumstances. Conforms a cross-reference. Repeals specified provision relating to optional coverage required for substance abuse impaired persons. Provides for application. EFFECTIVE DATE: 01/01/2011.  
12/9/2009 SENATE Referred to Banking and Insurance; Health Regulation; General Government Appropriations; Policy & Steering Committee on Ways and Means

**SB 0184 Relating to Adolescent Offenders/Parole** Joyner  
Adolescent Offenders/Parole [SPSC]; Provides that an adolescent offender who was 15 years of age or younger at the time of commission of an offense and who is sentenced to life or a single or cumulative term of 10 years or more in prison is eligible for parole if the offender has been incarcerated for a minimum period and has not previously been convicted of or adjudicated delinquent for certain offenses. Provides for retroactive application, etc. EFFECTIVE DATE: Upon becoming law.

**HB 0185 Relating to Children of Incarcerated Parents** Reed  
Children of Incarcerated Parents: Provides guiding principles to be used by state agency personnel when dealing with children of incarcerated parents. Effective Date: July 1, 2010

**SB 0194 Relating to Injunctions for Protection/Violations** Joyner

Domestic Violence/Injunction for Protection [SPSC]; Adds circumstances that violate an injunction for protection against repeat violence, sexual violence, or dating violence. EFFECTIVE DATE: 07/01/2010.

- HB 0201 Relating to Human Services Personnel** Porth  
Human Services Personnel: Designates act as "Protecting Florida's Most Vulnerable Citizens Act"; requires owner or operator of child care facility to report background screening results to DCFS before employing person at child care facility; prohibits hiring of person with disqualifying offense without being granted exemption; requires child welfare services staff to obtain child welfare certification; requires DCFS to designate credentialing entity to administer certification process; requires department to develop minimum trainer qualifications; revises administrative penalties; requires owner or administrator of assisted living facility to report background screening results to agency before employing person at assisted living facility; prohibits DCFS & AHCA from granting certain exemptions from disqualification from employment. Effective Date: July 1, 2010  
11/18/2009HOUSE Withdrawn prior to introduction
- SB 0204 Relating to Streamlined Sales and Use Tax Agreement** Lynn  
Streamlined Sales and Use Tax Agreement [WPSC]; Specifies certain facilities that are exempt from the transient rentals tax. Deletes criteria establishing circumstances under which taxes on the lease or rental of a motor vehicle are due. Limits the \$5,000 cap on discretionary sales surtax to the sale of motor vehicles, aircraft, boats, motor homes, manufactured homes, modular homes, and mobile homes. Revises exemptions from sales and use tax for food and medical products, etc. EFFECTIVE DATE: 01/01/2011.

- HB 0211 Relating to Juvenile Justice** Adams  
Juvenile Justice: Authorizes conditions of preadjudicatory release for certain children; permits child to be taken into custody for violations of preadjudicatory release conditions; provides that child taken into custody for violation of preadjudicatory release conditions must appear before judge within 24 hours; provides that detention care under specified provision does not require risk assessment; provides for certain kinds of care prior to hearing in certain circumstances; requires compliance with preadjudicatory release conditions; revises provisions relating to detention care; permits parent or guardian of child to be held in contempt if he or she fails to bring or otherwise prevents child from appearing; revises provisions relating to recommendations by probation officers concerning placement & treatment; specifies that court has power to determine appropriate dispositions; requires that reasons for disposition be stated; permits child to be detained in facility other than consequence unit for certain violations if one is unavailable; permits each county to create juvenile crime prevention fund & provides for additional court cost; provides that no juvenile shall be assessed additional court cost if juvenile & juvenile's parents or other legal guardian are indigent. Effective Date: July 1, 2010

- SB 0214 Relating to Autism and Other Developmental Disabilities** Ring  
Autism and Other Developmental Disabilities [SPSC]; Requires that a physician refer a minor to an appropriate specialist for screening for autism spectrum disorder under certain circumstances. Provides health insurance coverage for individuals with certain developmental disabilities. Requires the insurer's policy or the HMO's contract to provide a minimum number of visits per year for screening, evaluation, or diagnosis of autism spectrum disorder or other developmental disabilities, etc. EFFECTIVE DATE: 07/01/2010.

- HB 0217 Relating to Child-Restraint Requirements** Glorioso  
Child-Restraint Requirements: Provides child-restraint requirements for children 4-7 years old; provides exceptions; redefines term "motor vehicle" to exclude certain vehicles from such requirements; provides grace period. Effective Date: July 1, 2010  
10/29/2009HOUSE Withdrawn prior to introduction
- SB 0222 Relating to Childhood Vaccinations** Ring  
Childhood Vaccinations [SPSC]; Requires a pediatrician or attending physician to discuss the risks, benefits, and alternatives of each vaccination before a child is vaccinated. Provides requirements for the administration of certain vaccines required for school entry. Requires licensed health care providers to provide certain vaccine information statements to parents, legal guardians, and legal

representatives before administering certain vaccines to children, etc. EFFECTIVE DATE: 07/01/2010.

- HB 0223 Relating to Protection of Children** Williams (A)  
Protection of Children: Revises definition of "child care personnel" to include persons who work in summer 24-hour camps; requires summer day camps & summer 24-hour camps to be licensed by DCFS & requires employees thereof to undergo level 2 background screening; repeals exemption from fingerprinting requirements for summer camp personnel. Effective Date: July 1, 2010  
2/26/2010 HOUSE Withdrawn prior to introduction
- HB 0253 Relating to Space Shuttle Orbiter Retirement** Workman  
Space Shuttle Orbiter Retirement: Urges Congress to direct that one of retiring space shuttle orbiters be preserved & placed on permanent display at Kennedy Space Center. Effective Date: Not Specified  
11/16/2009HOUSE Now in Economic Development & Community Affairs Policy Council
- SB 0262 Relating to Affordable Housing** Bennett  
Affordable Housing [EPSC]; Provides a housing finance authority with an additional purpose for which it may exercise its power to borrow. Revises provisions relating to the elements of local comprehensive plans to include an element for affordable housing for seniors. Revises the allocation of certain proceeds distributed from the excise tax on documents which are paid into the State Treasury to the credit of the State Housing Trust Fund, etc. EFFECTIVE DATE: 07/01/2010.  
4/6/2010 SENATE Favorable with CS by Finance and Tax; 5 Yeas, 0 Nays
- HB 0285 Relating to Liability Releases** Horner  
Liability Releases: Redefines term "nonspectators" to include minor on whose behalf natural guardian has signed motorsport liability release; provides that motorsport liability release signed by natural guardian on behalf of minor participating in sanctioned motorsports event is valid to same extent as for other nonspectators; limits validity of waiver or release signed by natural guardian on behalf of minor participating in activity at closed-course motorsport facility other than sanctioned motorsports event; authorizes natural guardians to waive, in advance, claims for injuries & property damage arising from risks inherent in commercial activity; defines term "inherent risk"; provides statement that must be included in waiver; creates rebuttable presumption that waiver is valid & that injury arose from inherent risk; provides requirements & standard of evidence for overcoming presumption; authorizes natural guardians to waive, in advance, any claim against noncommercial provider to extent allowed by common law. Effective Date: upon becoming a law  
3/25/2010 HOUSE Placed on Calendar, on second reading
- HB 0287 Relating to Homelessness** Pafford  
Homelessness: Requires DCFS to create lead agencies for homeless for certain purposes; transfers responsibilities & powers of local coalitions for homeless to lead agencies for homeless. Effective Date: July 1, 2010  
2/16/2010 HOUSE Withdrawn prior to introduction
- SB 0290 Relating to Florida Unborn Victims of Violence Act** Fasano  
Florida Unborn Victims of Violence Act [SPSC]; Defines the term "unborn child" for purposes of vehicular homicide. Revises terminology to refer to "unborn child" rather than "viable fetus." Provides that certain offenses relating to the killing of an unborn child by injury to the mother do not require specified knowledge or intent, etc. EFFECTIVE DATE: 10/01/2010.  
4/7/2010 SENATE Not Considered by Judiciary
- HB 0311 Relating to Debt Relief Services** Hudson  
Debt Relief Services: Revises definitions relating to debt relief services; provides powers of OFR; authorizes FSC to adopt rules; revises exceptions to Debt Relief Services Act; provides exception for attorneys representing clients; requires debt relief organizations to be registered with OFR; provides registration fee; requires background screening of applicants & control persons; provides grounds for registration issuance or denial; requires annual renewal; requires debt relief organization to obtain surety bond & to provide proof of such bond to OFR; requires debt relief organization to maintain records; requires debt relief organization to prepare financial analysis for debtor; provides for service contracts; requires certain provisions to be included in such contracts; requires debt relief organization to provide debtor with copies of all signed documents; prohibits debt relief organization

from engaging in certain additional specified acts; deletes provision that allows organization to collect fee for insufficient fund transactions; provides for debtor complaints to OFR; provides procedures & OFR duties; provides for issuance of subpoenas by OFR; authorizes OFR to issue cease & desist orders; provides penalties. Effective Date: January 1, 2011

- SB 0316 Relating to Child-restraint Requirements/Motor Vehicles** Altman  
Adoption: Prohibits adoption agency or entity from making suitability determinations based on, requiring disclosure relating to, or restricting lawful possession, storage, or use of firearm or ammunition; provides additional requirements for child-placing agencies; provides additional rulemaking requirements for DCF; creates additional grounds for denial, suspension, or revocation of license. Effective Date: April 6, 2010  
4/7/2010 SENATE Placed on Calendar, on second reading
- SB 0332 Relating to Debt Negotiation Services** Fasano  
Debt Negotiation Services [CPSC]; Provides that an attorney providing legal representation is exempt from debt negotiation organization requirements. Requires a debt negotiation organization to annually register with the OFR. Requires an annual fee. Specifies acts prohibited by a debt negotiation organization. Provides insurance requirements for such an organization. Provides requirements for debt negotiation service contracts, etc. EFFECTIVE DATE: 07/01/2010.  
1/5/2010 SENATE Withdrawn prior to introduction
- SB 0336 Relating to Adult Protective Services** Storms  
Adult Protective Services [SPSC]; Requires that the central abuse hotline, which is maintained by the Department of Children and Family Services, immediately transfer reports relating to vulnerable adults to the appropriate county sheriff's office. Authorizes the department to file a petition to determine incapacity. Prohibits the department from acting as guardian or providing legal counsel to the guardian, etc. EFFECTIVE DATE: 07/01/2010.  
2/8/2010 SENATE Now in Health and Human Services Appropriations
- SB 0348 Relating to Solicitation of Funds/Veterans' Organizations** Dean  
Solicitation of Funds/Veterans' Organizations [GPSC]; Exempts certain veterans' organizations from requirements to file registration statements with the Department of Agriculture and Consumer Services. EFFECTIVE DATE: 07/01/2010.  
12/9/2009 SENATE Referred to Military Affairs and Domestic Security; Commerce; General Government Appropriations
- HB 0361 Relating to Trust Administration** Wood  
Trust Administration: Limits personal representative's entitlement to payment from trust of specified estate expenses & obligations; specifies application of specified criteria in making payments from trust; specifies application of additional provisions to liability for specified estate expense & obligation payments from trust; deletes notice requirements relating to court review of trustee's employment of specified persons; authorizes rather than requires award of expert witness fees from trust assets; provides authority for court interpretation of specified trusts not subject to federal estate tax; authorizes trustee to take specified actions pending determination of trust distribution; limits trustee liability; provides criteria for determining who contributed trust assets; requires application of priorities for pro rata abatement of nonresiduary trust dispositions together with nonresiduary devises; deletes authority for court to determine attorney's compensation; deletes expert testimony & fee payment provisions; deletes requirements for court compensation determination proceedings to be part of trust administration process & for court determination & payment of specified estate costs & fees from trust assets. Effective Date: July 1, 2010

- HB 0383 Relating to Voluntary Prekindergarten Education Program** Long  
Voluntary Prekindergarten Education Program: Provides that prekindergarten instructors in school-year prekindergarten programs delivered by private providers & public schools must meet new professional credentialing requirements beginning July 1, 2013; repeals provisions relating to aspirational goals for professional credentials of prekindergarten instructors. Effective Date: July 1, 2013  
12/18/2009HOUSE Referred to Insurance, Business & Financial Affairs Policy Committee; Policy Council; PreK-12 Appropriations Committee; General Government Policy Council

- HB 0387 Relating to Child-restraint Requirements** Glorioso  
Child-restraint Requirements: Provides child-restraint requirements for certain children ages 4 through 7; redefines term "motor vehicle" to exclude certain vehicles from such requirements; provides grace period & exceptions. Effective Date: July 1, 2010  
12/18/2009 HOUSE Referred to Roads, Bridges & Ports Policy Committee; Full Appropriations Council on Education & Economic Development; Economic Development & Community Affairs Policy Council
- SB 0400 Relating to Programs to Prevent Violence** Fasano  
Programs to Prevent Violence [SPSC]; Requires that an additional or increased court cost or surcharge be assessed against a defendant who pleads guilty or nolo contendere to, or is found guilty of, regardless of adjudication, certain specified criminal offenses. Provides for proceeds of the additional court cost or surcharge to be deposited into the Rape Crisis Program Trust Fund or the Domestic Violence Trust Fund, etc. EFFECTIVE DATE: 07/01/2010.  
3/15/2010 SENATE Now in Health and Human Services Appropriations
- SB 0404 Relating to Children of Incarcerated Parents** Joyner  
Children of Incarcerated Parents [SPSC]; Provides legislative findings and purpose. Provides guiding principles to be used by state agency personnel when dealing with children of incarcerated parents. Provides for applicability. EFFECTIVE DATE: 07/01/2010.

- HB 0411 Relating to Child Care Facilities** Nehr  
Child Care Facilities: Provides for certain household children to be included in calculations regarding capacity of licensed family day care homes & large family child care homes; provides conditions for supervision of household children of operators of family day care homes & large family child care homes; revises advertising requirements applicable to child care facilities; provides penalties. Effective Date: July 1, 2010  
3/2/2010 HOUSE Placed on Calendar, on second reading
- SB 0412 Relating to Emergency Management** Bullard (L)  
Emergency Management [SPSC]; Requires the DCFS, to the extent permitted by federal law, to expedite application procedures for persons who reside in an area damaged by a major disaster and who apply for temporary cash assistance. Provides restrictions on the use of such restraints and seclusion.
